Section 4 – Terms and Conditions

To be eligible for consideration by the City for a Residential Stump Rebate (the "Program"):

- 1. Applying does not guarantee a rebate. Rebates are issued on a "first-come, first-serve" basis, and are subject to funding limits.
- 2. To be eligible for consideration for a rebate under the Program:
 - a. You must be the registered owner of a single-family residential, duplex or triplex property within the City of Charlottetown (rental properties or businesses are not eligible).
 - b. The rebate is available only to existing homes, not homes in the planning stages, currently under construction or vacant land.
 - c. Only one rebate can be requested per household.
 - d. Front yard stumps are eligible, or back yard and side yard if a hazard.
 - e. Stump/s must be 30cm or greater in diameter.
 - f. You must submit your application and invoice for work by a licensed business.
- 3. In applying to the Program, and as a condition of eligibility for a rebate, I understand and agree to the following:
 - a. I am solely responsible for the work being done on my property.
 - b. The City assumes no liability whatsoever relating to the work being undertaken to be eligible for the rebate.
 - c. The City of Charlottetown does not:
 - i. endorse specific contractors.
 - ii. guarantee materials, workmanship, or performance of contractors.
 - d. The City of Charlottetown reserves the right, at any time, to cancel the Program or the payment of any rebates under it, in the event that funding is no longer available under the Program, or the Program is cancelled by the City.
 - e. By signing this application, the property owner agrees to assume all financial and other responsibility for all work whatsoever in respect to the stumping, which may be eligible for a rebate under the Program, including, without limitation, the selection of the contractors and any consequences arising from the work and the compliance with all laws in respect to such works.
 - f. The Applicant fully and completely, without qualification, agrees hereby to waive and release and shall be deemed to have waived and released the City of Charlottetown, its officials, officers, employees, agents and representatives (collectively, the "City") from and against any claims or liabilities whatsoever including, without limitation, any damages, costs and liability for any and all loss, injury or damage to any property or person, whether direct, special, consequential, indirect or of any other nature, in connection with or related to the participation in this Program (collectively, "Claims").
 - g. I will not make any Claims or take any action against the City and agree to indemnify the City against any Claims made or taken by someone else.
 - h. If any incorrect or deceptive information, statement or representation is found in this application or the accompanying documents, the City is entitled to:
 - i. reject my application
 - ii. demand full and immediate repayment of any subsidy money paid to me
 - iii. prosecute me or take other legal action against me

Subject to any reserved rights of the City, no payment of a rebate under this Program shall be made unless all terms and conditions of this application and Program have been met.

If your application is incomplete, or you have not included the required documentation, your application will not be processed and will be returned with a request for the outstanding information.
