City of Charlottetown, PEI A Bylaw to Amend the City of Charlottetown COVID-19 Temporary Patio Program Bylaw Bylaw # 2020-CTP-01B

BE IT ENACTED by the Council of the City of Charlottetown as follows:

PART I – INTERPRETATION AND APPLICATION

1. Title

1.1 This bylaw shall be known and cited as the "COVID-19 Temporary Patio Program Amendment Bylaw."

2. Purpose

2.1 The purpose of this bylaw is to amend the City of Charlottetown's COVID-19 Temporary Patio Program Bylaw to extend the program until October 31, 2023 and to increase the fees to align with the Street Vendors Bylaw.

3. Authority

Pursuant to Part 5, Section 134(1)(i) of the Municipal Government Act R.S.P.E.I. 1988, Cap. M 12.1., Revision of Bylaws – make changes, without changing the substance of a bylaw, to bring out more clearly what is considered to be the meaning of the bylaw or to improve the expression of the law.

4. Definitions

- 4.1 In this bylaw, any word and term that is defined in the *Municipal Government Act* or The City of Charlottetown COVID-19 Temporary Patio Program Bylaw has the same meaning as in that Act or bylaw.
- 5. Section 6 Administration of the City of Charlottetown COVID-19 Temporary Patio Program Bylaw is hereby amended by the following:
 - 5.1 In subsection 6.4, amend the effective date of applications for temporary patios from October 31, 2021 to **October 31, 2023**.
 - 5.2 In subsection 6.6, amend schedule "C" from \$300.00 per parking space to \$600.00 per parking space to align with the Street Vendors Bylaw.

Part II - Approval and Adoption

Effective Date

6.1 This COVID-19 Temporary Patio Program Amendment Bylaw, #2020-CTP-01B, shall be effective on the date of approval and adoption below.
